Each semester we offer a variety of **Advanced Legal Research** courses, most of which have been approved for experiential credit. This semester our Advanced Legal Research courses have a total enrollment of more than **100 students**.

In addition to a three credit **workshop** and several one credit **weekend courses** covering legal research generally, we are offering subject specific research courses on subjects such as:

- **taxation**
- **public interest law**
- **foreign & international law**
- **intellectual property**

We are also offering our pioneering **Law Practice Technology** seminar for the second time.

### 2018 AALS Meeting

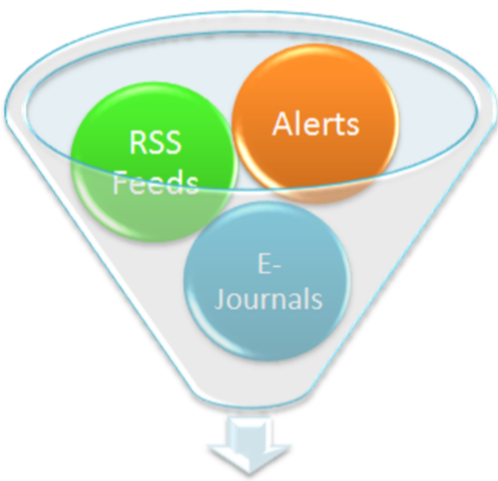
Library directors at law schools across the country are working with faculty, administrators, and students to address the challenges to the practice of law brought by rapid technological change. At a number of formal and informal meetings held at this year's AALS Annual Meeting, I heard about library-based initiatives designed to improve the technological competency of law school graduates including:

- office technology assessment and training programs
- training modules offered by librarians within traditional substantive law courses
- instructional brown bags on topics such as e-discovery and docket analytics
- stand-alone law practice technology courses.



The Maloney Library will be rolling out a number of initiatives of this type over the next few semesters in addition to teaching **Law Practice Technology** seminar.
