DETAILED PRESENT OFFENSE: : On 12/28/88 at an Amoco Gas Station located at the corner of Utica Avenue and Northland Road the subject and an unapprehended accomplice approached the victim, a cab driver, and began to wrestle. The Subject and the unapprehended perpetrator left momentarily and retrieved a shotgun. A witness overheard the victim stating, " I have no money" and then a gun shot. The Subject and unapprehended accomplice fled from the scene. Officers searched the area and the subject fit the description provided by the witness and was called over by the officer. The officer observed the subject huffing, puffing and perspiring. Subject advised he was on his way to work but accompanied the officer back to the scene of the offense. The Subject was positively identified at the scene by a witness. The Victim was pronounced dead at the scene by an EMS technician.

OFFENDER STATEMENT: Subject was interviewed on 7/31/19 at the Ulster Correctional Facility. The Subject was asked if he has an appeal pending, He advised that he does not have an appeal pending nor does he plan on filing an appeal. Regarding the instant offense, the subject admits guilt. The subject was asked if he wanted to make a statement. Subject wished to make the following statement "The remorse I have for the crime I committed and the empathy I feel for Mr. Lagent's family is so deep, that I knew I had to do something to change my life around. I do not want anyone to ever feel that kind of hurt and pain again because of me. I respectfully request that the commissioners review my parole packet and personal statement."

For the purposes of this section an "area accessible to the public" shall mean sidewalks, streets, parking lots, parks, playgrounds, stores and restaurants.
