

DETAILED PRESENT OFFENSE: On May 21, 1971, two police officers were exiting [REDACTED] after responding to a call from a female residing at the aforementioned address. As the officers approximated their vehicle, the subject shot one of the officers four times in the back of his head. Then the subject's codefendant ([REDACTED]) shot the other officer. Once the second officer fell to the ground, the subject proceeded to shoot at this second officer as well. The subject and his codefendant proceeded to remove the officer's gun and fled the scene. Both officers died. On August 28, 1971, the subject and codefendant [REDACTED] were apprehended on an unrelated charge in San Francisco, CA. It was determined that this codefendant was in possession of one of the guns of one of the officers that were killed on May 21, 1971. The subject was in possession of one of the guns that were used to kill the police officers.

OFFENDER STATEMENT: Inmate was interviewed at Sullivan CF on 6/26/19. He was informed that anything he says in this interview could be used in further proceedings. The subject was convicted by verdict, he was advised of his rights regarding discussion of the instant offense. Regarding his offense, the subject said he will provide a written statement.
