SUMMARY/EVALUATION: Subject is a 54-year-old male serving his fourth NYSDOCCS term for Attempted Robbery 2nd with an aggregate term of 12/Life. Inmate was on Parole supervision at the time of the instant offense. In the instant offense, inmate robbed the male victim at gunpoint, threatened to shoot the male victim if he moved and demanded his chain and money. Inmates criminal history commenced at the age of 11 with a total of 22 arrests. Inmate has received six Tier III and five Tier II misbehavior reports during his incarceration. Inmate has completed the following required programs: Vocational, ASAT, ART, Transitional Services Phase I and Phase II. He needs to complete the following required program: Transitional Services Phase III. Inmate has been programming as a Student in the two-year degree program since 08/2019.
