DETAILED PRESENT OFFENSE: Records indicate that on 12/16/81 at approximately 8:50 pm, victim was returning to his home located at [REDACTED]. As he exited his vehicle, three males emerged from the bushes and stated " this is a robbery ". Victim began to scream and his son-in-law, a police officer, emerged from the house. He announced " Police ! , Don't Move ! ". The perpetrators turned and fired a at the Police Officer, striking him in the chest which resulted in his death. They also robbed victim of his currency and his vehicle. At this point , police officer's spouse and her brother, emerged from the house and were fired upon as well. The perpetrators fled in victim's vehicle. The autopsy report indicated that the victim, Police Officer died of gunshot wounds to the chest, right main pulmonary artery, and right lung. The victim left behind a wife and child.

OFFENDER STATEMENT: The subject was interviewed on 8/28/2018 at Green Haven Correctional Facility. Subject continues to admit guilt in the instant offense and takes full ownership for his actions. He states that he cannot undo what was done, but says he can impact others in a positive way upon his release and while in jail. Subject admits to being present at the time the instant offense occurred, but stated that his co-defendant, [REDACTED], was the one who shot the victim. He also stated that he did not know that the offense was going to happen and that these people were "random victims".
