DETAILED PRESENT OFFENSE: Ind [REDACTED]. On 3/29/91 between 9:00PM and 11:30PM inside of [REDACTED] NY Co-defendant [REDACTED] held the victim, [REDACTED] at gunpoint while the subject, co-defendant [REDACTED] (the subject's brother) and an unapprehended male raped, sodomized and had oral sex with her. Afterwards, Co-defendant [REDACTED] punched the victim in the face and body causing lacerations to the victim's face and knee. The victim was also robbed of her gold earrings and two bracelets. The victim was released after several hours, and went to the [REDACTED]<sup>th</sup> police precinct. The subject also fled the scene.

OFFENDER STATEMENT: Inmate, [REDACTED], [REDACTED], was interviewed at Woodbourne Correctional Facility on 8/8/18. Subject stated, "Through therapeutic programming and participation I have learned a great deal about having empathy for others. I have also reflected on my upbringing and how that has affected my decision making."
