**DETAILED PRESENT OFFENSE:** On 12/2/81, inside the lobby of [REDACTED], at approximately 4:15pm, the subject and one other entered [REDACTED] - an adult education center and the victim's place of employment. The subject posed as a flower delivery man and insisted that the victim, his estranged wife, personally sign for the flowers at the front desk. The victim met with the subject and refused to speak with him. The subject followed her and stabbed her to death. The subject also stabbed a second victim who attempted to protect the first victim, causing serious injury to the second victim's hand. The medical examiner gave immediate cause of death as stab wound of the chest, abdomen, and extremity, penetrating lung, heart, aorta, pulmonary artery, esophagus and pericardium ad incised wound of the right hand. External and internal hemorrhages. He was arrested 3/22/82.

**OFFENDER STATEMENT:** Subject was interviewed at Otisville CF on 3/9/18. He admits guilt and would like to provide his own personal written statement, but also states he stands by his prior statement "I am very remorseful, I regret that it happened and I miss my wife and kids very much, this horrible experience will never leave me."
