LawTech@Maloney Library

The Maloney Library's slate of legal technology initiatives, LawTech@Maloney Library, designed to promote technological competence in our students, ramped up this year with the following fall highlights

- Lunch 'n' Learns, *AI in Legal Practice* and *Blockchain for Lawyers*, featured vendor representatives from leading legal technology vendors Luminance and Thomson Reuters.
- E-Discovery hands-on intro class was offered as a "plug-in" class module. Module was delivered to Professor Landau's MSL course, Introduction to the American Legal System.
- Procertas online law office training modules in MSWord, Excel, and PDF were made available to all Fordham 2L and 3L students.

For spring 2020 we will offer another slate of Lunch 'n' Learns delivered by representatives of major legal technology vendors designed to familiarize students with the legal technologies that they are likely to encounter in practice. We will continue to deliver our well-regarded hands-on e-discovery introduction in Civil Procedure sections and in other classes, as invited. We will be administering a mandatory online Procertas training program for MSWord in 1L legal writing. Finally, we will be offering our two-credit Law Practice Technology course, now in its fourth year.
