WORTHY OF NOTE

In the Spring of 1988, Fordham's BLSA adopted its Constitution. The Constitution defines Fordham BLSA's goals and objectives.

The Constitution emphasizes BLSA's commitment to increasing Black representation at Fordham Law School by the formation of a Recruitment Committee. This committee will work with Fordham's Administration in recruiting Black students. Additionally, the committee will implement its own programs and work in conjunction with other law schools in BLSA's Subregion to further this effort. The Chairperson of the Recruitment Committee for 1988-89 is Andrew Hinton.

In addition to the Recruitment Committee, other committees were established such as the Mentor/Mentee Committee. This committee pairs an upperclass student with a first-year student to assist the first-year in the law school transition. The Chairperson of the Mentor/Mentee Committee is Susan Piesley. Other committees established by the Constitution and their Chairpersons include: the Community Affairs Committee -- Chairperson, Marcia Thurmond; Special Events Committee -- Chairperson, Janice Smith; and the Alumni Affairs Committee -- Chairperson, John Johnson. We welcome any suggestions and assistance you can give to these committees.

A new Executive Committee position was also established in the Constitution that of Abregional Representative. The duties of this

position include representing Fordham at all BLSA subregional meetings and conferences. The subregion consists of the BLSA chapters from Fordham, New York University, Columbia, St. John's, Rutgers, Seton Hall, Cardozo, Brooklyn, CUNY, Touro, Pace, New York Law and Hofstra. This position allows Fordham's BLSA to participate in activities beyond the immediate Fordham community.
