Library Fest Success!




Over 400 students attended Library Fest at the Maloney Library!

Online Textbook for Basic Legal Research



This summer, the law library's instruction team wrote a free, online textbook for students to use for the Basic Legal Research component of the first-year Legal Writing & Research course. Broken down by the stages of the Four-Step Legal Research Process we use to teach legal research, it includes a general overview of each step of the process, as well as a large number of embedded videos demonstrating basic search strategies for secondary sources, statutes, cases, and regulations. The textbook is a resource students can use throughout their law school careers and beyond when they have questions about legal research.

A new volume, entitled **Doctrine & Diversity: Inclusion and Equity in the Law School Classroom**, is a collection of essays with practical advice on specific ways to integrate diversity, equity, and inclusion into each first-year law school course.
