<b>DETAILED PRESENT OFFENSE:</b> On 3/9/94, the subject entered the home of his next door neighbor in pursuit of the 25 year old daughter (victim) who was caring for the home while her father was away. The subject shut off the main electrical breaker so that the house was in total darkness, and then grabbed and wrestled with the victim, strangling her into unconsiousness. He then taped her eyes and mouth shut and took her into an upstairs bathroom where he sexually fondled her and then strangled her a second time until he was sure she was dead. He carried her to his own residence and then returned next door to clean up the signs of a struggle with the victim, and turned the lights back on. Afterwards, he placed her body in a van in his garage. The following day he took her body to Sunken Meadow Park where he hid her body in a shallow grave and covered it with brush.
