DETAILED PRESENT OFFENSE: INDICTMENT on 08/13/1971, subject approached a nine year old female who was playing in the company of her eleven year old sister and lured her into going with him into a deserted area of a park near the Bronx Zoo. The subject offered the nine-year-old victim candy, grabbed her by her hand and took her away. Once away from the place in which he found her, he subjected the victim to brutal sexual and physical abuse. The victim's body was found to have multiple lacerations and a fractured skull, among other contusions. The subject raped the nine-year-old victim and killed her, leaving her body in a river, in the area of the Bronx Zoo. When found, subject had stains of blood on his clothing and his upper torso had scratches.					
<b>OFFENDER STATEMENT:</b> The subject was interviewed at Woodbourne Correctional Facility on 03/04/2021. Concerning the instant offense, the subject stated "I am very sorry for what I did. No matter what I say, it could never be enough to show you how sorry I am."
