It's frustrating when links to resources the library subscribes to are behind a paywall when accessed outside of the Law School, for example, links to articles in email alerts from the [Chronicle of Higher Education](#) or [HeinOnline](#).

[Maloney Link](#) is a new utility that can fix this. Simply follow the instructions here, and using [Maloney Link](#) will change the stubborn URL to allow access. You'll automatically be prompted to authenticate using your Access IT ID, and as long as the Library subscribes to the target resource, you'll be able to view it!
