FRITZ MONDALE AND I SHARE THOSE CONCERNS. WE KNOW THAT ENSURING ALL OF OUR CITIZENS ACCESS TO AFFORDABLE, QUALITY HEALTH CARE IS ONE OF THE MOST IMPORTANT RESPONSIBILITIES OF THE GOVERNMENT.

I KNOW THAT YOU ARE ALSO CONCERNED -- AND YOU SHOULD BE -- ABOUT BEING TREATED EQUITABLY AS WE STRIVE TO MAKE HEALTH CARE AFFORDABLE FOR EVERYONE.

FRITZ MONDALE AND I BELIEVE IN EQUAL PAY FOR EQUAL WORK. YOU FINOW. IWENTY YEARS AGO THE AVERAGE FULL TIME FEMALE WORKER IN THIS COUNTRY EARRED SIXTY PERCENT AS MUCH AS HER MALE COUNTERPART. A GENERALION LATER, WE'VE SENT A MAN TO THE MOON AND WE'VE CRACKED THE GENETIC CODE. BUT WOMEN STILL EARN EIETY-NINE CENTS TO A MAN'E DOLLAR.

WHEN RONALD REAGAN TOOK OFFICE. HE FIRST FROZE AND THEN ELIMINATED PAY EQUITY REGULATIONS THAT PROHIBITED SEX AND RACE DISCRIMINATION BY FEDERAL CONTRACTORS.
