

## EXAMINATION BY COMMISSIONER LUDLOW:

I don't know if he did at the sentencing. That how it goes. That's what he said, he's directing them not to let me go until at least 25 years.

Q. I am reading from a comment in the presentence transcript from page six, wherein the Judge states as follows, "We learned from a trial the true facts of the case. Up to that point I had the opinion he was not the person responsible for this death. I am satisfied after the trial, he was the one, he's the killer."

He's talking about you, correct?

run concurrent."

- Q. Was the judge speaking the truth, did you strangle the old man at the clothing store?

Seeing this all through the years, I visualize in my mind, I would like to be like them sometime, you know? Working, I see what it's about, it's accountability and responsibility, is the big picture. I see and I say this is what I want, to be like them. That's when I got more involved in the vocationals and therapeutic programs so I could be a productive citizen to be like them. This is something I never got to see when I was in the street. I been in here more than half my life. I see the civilians: We are going on vacation, we be back such and such. And I was like, this is what it's about.

Q. That's well stated. We appreciate your thoughts in that regard.

We have attempted to give you a full, fair and accurate interview tonight. In your opinion, have you received that?

A. Yes.

I smoked a little marijuana, maybe I drunk, had a dirty urine and I had an incident with the police, an assault which I was in keep lock which I am sure you have it on record. At the time I was in keep lock, that charge was a smuggling charge when I was locked up at that time. What happened, someone put a letter in -- put my name and number on the envelope. And at the hearing I tried to get witnesses, write in material to compare it. And the Sergeant I was working for at the time, Sergeant at that time, got me all the materials to show this wasn't me, the handwriting. I don't know if you still got the letter there. They said the facility keeps it. The hearing officer never believed me. guy that signed it signed it with a dash, , do or die. This is a place in I lived on at the time. The hearing officer said: I used to live in on years ago. My point is, at that time when I was keep lock I was feeling real bad and one time the police was coming by, doing his rounds.

I been trying to get him the whole day. I stuck my hand

out to grab his attention, and when I put my hand out to the grab him he grabbed my hand, and I did spit him in the face because I thought he was going to break my arm. He was new. I figured that's how he will let go of me.

Next day I saw him, went to the hearing, I spoke to him, I apologized. We started talking, I landed on his gallery and I was with him for a while. And since that time I was working with staff and I just wanted you to know that.

COMMISSIONER LUDLOW: We appreciate the clarification. We wish you good luck, Mr.

### DECISION:

Parole is denied. Hold 24 months, next appearance December 2009. Following careful review and deliberation of your record and interview, this panel concludes that discretionary release is not presently warranted due to concern for the public safety and welfare. The following factors were properly weighed and considered: instant offense in in 1983, involved you and co-defendants robbing a clothing store owner wherein the victim was killed. Your criminal history includes a criminal trespass related offense. Your institutional programming demonstrates progress and achievement, which is to your credit. Your disciplinary record reflects ten tier-2 and five tier-3 reports. The extreme violence and resulting death of the victim as indicated in the instant offense and your disciplinary record are of serious concern to this panel as it relates to the public safety. Your discretionary release at this time would thus, not be compatible with the welfare of society at large and would tend to deprecate the seriousness of the instant offenses and undermine respect for the law.
