PAROLE IS DENIED. AFTER A PERSONAL INTERVIEW, RECORD REVIEW AND DELIBERATION, IT IS THE DETERMINATION OF THIS PANEL THAT YOUR RELEASE IS INCOMPATIBLE WITH THE WELFARE AND SAFETY OF THE COMMUNITY. CONSIDERATION HAS BEEN GIVEN TO AN ASSESSMENT OF YOUR RISK AND NEEDS FOR SUCCESS ON PAROLE. THIS PANEL NOTES YOUR CASE PLAN, YOUR RELEASE PLANS AND INSTITUTIONAL RECORD WHILE SERVING THIS STATE BID AND SEVERAL LETTERS OF SUPPORT. HOWEVER, MORE COMPELLING IS YOUR SERIOUS INSTANT OFFENSES OF MURDER 2ND AND MANSLAUGHTER 1ST WHICH INVOLVED YOUR CAUSING THE DEATH OF ANOTHER HUMAN BEING, A YOUNG CHILD. YOUR CRIME WAS BRUTAL AND SENSELESS AND A TOTAL DISREGARD FOR HUMAN LIFE. WHEN CONSIDERING ALL RELEVANT FACTORS, YOUR RELEASE WOULD SO DEPRECATE THE SERIOUS NATURE OF YOUR CRIME AS TO UNDERMINE RESPECT FOR THE LAW.
