- ANTISLAVERY.** Dwight Lowell Dumond. Ann Arbor: The University of Michigan Press. 1961. Pp. x, 422. \$20.00. Documentation of man's inhumanity to man, race relations, and the origins of the Civil War. The courageous struggle against the emotions and mores of slavery depicted in shocking detail.
- THE ART OF THINKING.** Dagobert D. Runes. New York: Philosophical Library. 1961. Pp. 90. \$2.75. A study of the role of emotional elements in the formulation of logical propositions.
- CONDEMNATION APPRAISAL PRACTICE.** Chicago: American Institute of Real Estate Appraisers. 1961. Pp. xvi, 536. \$12.50. Modern principles, procedures, and problems of eminent domain presented in a series of articles by judges, attorneys, and appraisers.
- CONSCIENCE IN POLITICS.** Stuart Gerry Brown. Syracuse: Syracuse University Press. 1961. Pp. xi, 313. \$4.50. A critical perception into the period from 1952-1960 and the leadership of Adlai E. Stevenson.
- DEATH AND THE SUPREME COURT.** Barrett Prettyman, Jr. New York: Harcourt, Brace & World, Inc. 1961. Pp. 311. \$4.95. Narration of six crimes from the investigation procedure through the last appeal to the highest court of the land.
- EUROPE'S NEEDS & RESOURCES.** J. Frederic Dewhurst, John O. Coppock, P. Lamartine Yates & Associates. New York: The Twentieth Century Fund. 1961. Pp. xxvi, 1198. \$12.00. An exhaustive, scholarly, and international study which researches the remarkable recovery of Western Europe and analyzes its present resources and future prospects.
- ***THE FOREIGN TAX CREDIT.** Elisabeth A. Owens. Cambridge: The Law School of Harvard University. 1961. Pp. xii, 634. \$20.00.
- FREEDOM AND THE LAW.** Bruno Leoni. Princeton: D. Van Nostrand Company, Inc. 1961. Pp. vii, 204. \$6.00. A view of contemporary philosophy, judicial decision, and legislation as restricting individual freedom, with a plea for "golden rule" jurisprudence.
- FREEDOM AND RESPONSIBILITY.** Edited by Herbert Morris. Stanford: Stanford University Press. 1961. Pp. ix, 547. \$11.50. A collection of legal and philosophical writings centered on responsibility and some component concepts—the will, act, intent, motive, negligence, causation, ignorance, legal insanity, and punishment.
- THE GREAT IDEAS TODAY.** Edited by Robert M. Hutchins and Mortimer J. Adler. Chicago: Encyclopaedia Britannica, Inc. 1961. Pp. xi, 562. \$8.95. The wisdom of the ages applied to modern problems, democracy for the new nations, review of world affairs, and developments in the arts and sciences are analyzed with a diversity of philosophies including those of Mr. Justice Douglas, Mark Van Doren and George P. Grant.
- HANDBOOK FOR JUDGES.** Edited by Donald K. Carroll. Chicago: American Judicature Society. 1961. Pp. vi, 195. \$3.50. An anthology of writings discussing the ethical, spiritual and essential qualities of the judiciary and its role in civilization.

THE IDEA OF FREEDOM. Mortimer J. Adler. Garden City: Doubleday & Company, Inc. 2d vol. 1961. Pp. x, 754. \$7.50. The pros and cons of the five distinct freedoms—circumstantial freedom of self-realization, acquired freedom of self-perfection, natural freedom of self-determination, political liberty, and collective freedom—are thoroughly analyzed and criticized.

THE MAKING OF THE GOOD NEIGHBOR POLICY. Bryce Wood. New York: Columbia University Press. 1961. Pp. x, 438. \$7.50. The rationale behind the abandonment of American intervention in Latin-American affairs in favor of the Good Neighbor policy is developed with emphasis on the growth of compromise and collaboration.

A survey into several areas of tax law embracing administration, electronic processing, intra jurisdictional problems, assessments, and uniformity.

MY LIFE IN COURT. Louis Nizer. Garden City: Doubleday & Company, Inc. 1961. Pp. 524. \$5.95. A renowned trial lawyer's enjoyable and informative account of some of his major cases.

RECOGNITION OF COMMUNIST CHINA. Robert P. Newman. New York: The Macmillan Company. 1961. Pp. xii, 318. \$4.95. The author treats this controversial topic on three levels—moral, political, and legal—concluding that recognition should be given.

THE RULE OF LAW. Edited by Arthur L. Harding. Dallas: Southern Methodist University Press. 1961. Pp. xi, 89. \$3.00. The rule of law contemplated in light of American experience and international application.

WAGES IN THE METROPOLIS. Martin Segal. Cambridge: Harvard University Press. 1960. Pp. xi, 211. \$4.75. Continuation of a series of books on the forces which shape metropolitan areas. The emphasis is on wage levels and their influence on the location and development of industries within the New York metropolitan area.
