- THE AMERICAN FEDERAL EXECUTIVE. By W. Lloyd Warner, Paul P. Van Riper, Norman H. Martin and Orvis F. Collins. New Haven and London: Yale University Press. 1963. Pp. xvii, 405. \$7.50. This study projects the composite image of the elite of the civil, foreign and military services, their backgrounds, education, marriages and careers.
