- AMERICAN EDUCATION—A NATIONAL FAILURE. By H. G. Rickover. New York: E. P. Dutton & Co. Inc. 1963. Pp. viii, 502. \$1.95 paperbound. An examination of the American system of education and proposals for correction, based largely on the author's report to the House Appropriations Committee.
- AMERICAN ENTERPRISE AND SCANDINAVIAN ANTITRUST LAW. By E. Ernest Goldstein. Austin: University of Texas Press. 1963. Pp. ix, 391. \$6.50. The author tells how the laws of each country are administered, and he provides a basis for evaluating the administrative process in Scandinavia, for understanding the Scandinavian administrator, for comparing laws among the three countries, and for understanding foreign antitrust laws generally.
- BELLI LOOKS AT LIFE AND LAW IN RUSSIA. By Melvin M. Belli and Danny R. Jones. Indianapolis and New York: The Bobbs-Merrill Company Inc. 1963. Pp. 381. \$5.50. Comparisons between life and law in Russia and in America by the authors of *Life and Law in Japan*.
- *THE BUSINESS CONSCIENCE. By Luther H. Hodges. Englewood Cliffs: Prentice-Hall, Inc. 1963. Pp. x, 250. \$4.00.
- CITY POLITICS. By Edward C. Vanfield and James Q. Wilson. Cambridge: Harvard University Press and the M.I.T. Press. 1963. Pp. 362. \$6.95. Without neglecting the legal formal machinery of government, these two authors emphasize the differences of opinion and interest that exist within the cities, the issues that arise from these differences, and the ways in which institutions resolve or fail to resolve them.
- COMPARATIVE LAW AND SOCIAL THEORY. By Jerome Hall. Baton Rouge: Louisiana State University Press. 1963. Pp. vi, 167. \$5.00. The author's thesis is that all social science should be legally oriented.
- THE CONCEPT OF JACKSONIAN DEMOCRACY: NEW YORK AS A TEST CASE. By Lee Benson. New York: Atheneum. 1964. Pp. xv, 351. \$1.95 paperbound. An examination of the impact of equalitarian ideas upon New York politics from 1816 to 1844 and an essay on the clarification of historical concepts.
- CONTRACTS AND CONVEYANCES OF REAL PROPERTY. By Milton R. Friedman. New York: Practising Law Institute. 2d. ed. 1963. Pp. xii, 700. \$20.00. Intended for the practitioner, this guidebook deals with real estate transactions from the inception of the contract through the delivery of the deed.
- COPYRIGHTS. By Barbara A. Ringer and Paul Gitlin. New York: Practising Law Institute. 1963. Pp. 162. \$5.00 paperbound. A guide book which covers national and international copyrights and analyzes the copyright laws and their application.
- CORPORATE PRACTICE. By Carlos L. Israels. New York: Practising Law Institute. 1963. Pp. xix, 606. \$15.00. Keyed to the corporation statutes of New York and Delaware, this book is designed to fill the need for a re-examination of corporate practice in all jurisdictions.
- THE DOLCIN CASE AND THE FEDERAL TRADE COMMISSION. By Joseph C. Palamountain, Jr. University: University of Alabama Press. 1963. Pp. 64. \$1.95 paperbound. Primarily intended for the student of regulatory administration, the significance of this book touches the fields of administrative law, food and drug law, pharmacology and advertising.

- EAST AND WEST. By C. Northcote Parkinson. Boston: Houghton Mifflin Company. 1963. Pp. xxii, 330. \$5.00. The author, a historian and political scientist, examines the alternations of power in the world's history and observes a pattern.
- THE ECONOMISTS OF THE NEW FRONTIER. Edited by B. Hughel Wilkins and Charles B. Friday. New York: Random House. 1963. Pp. ix, 338. \$5.95. Designed as an anthology of current economic thought and as an introduction to modern economics, the book includes selections from the works of several persons who determined the economics of the Kennedy administration.
- EISENHOWER, BROWNELL, AND THE CONGRESS: THE TANGLED ORIGINS OF THE CIVIL RIGHTS BILL OF 1956-1957. By J. W. Anderson. University: University of Alabama Press. 1964. Pp. viii, 139. \$3.95. A comprehensive picture of the complex forces that affect the writing and introduction of a major piece of legislation, and the equally complex forces that influence policy-making in the Congress.
- THE ELECTION OF ANDREW JACKSON. By Robert V. Remini. Philadelphia and New York: J. B. Lippincott Company. 1963. Pp. 224. \$4.50. The story of the changes that took place in American politics during the contest between Andrew Jackson and John Quincy Adams and the resulting reappearance of the two-party system in American political life as a permanent fixture.
- I WAS A FIVE-DOLLAR LAWYER. By Hiram E. Casey. New York: Exposition Press. 1963. Pp. 92. \$3.00. A lawyer's memories of fifty-two years of experience.
- LAW IN A BUSINESS SOCIETY. By Jacob Weissman. Englewood Cliffs: Prentice-Hall, Inc. 1964. Pp. xiv, 110, \$1.75 paperbound. Another volume in the Foundations of Law in a Business Society Series, Edited by Cornelius W. Gillam.
- THE LAW OF SUBDIVISIONS. By E. C. Yokley. Charlottesville: The Michie Company. 1963. Pp. xvi, 492. \$20.00. Equipped for pocket supplements, this work spells out the rights of approving agencies and subdividers.
- MANUAL OF FEDERAL TRADE REGULATIONS AFFECTING RETAILERS. Edited by James J. Bliss and Ira M. Millstein. New York: National Retail Merchants Association and Practising Law Institute. 1963. Pp. x, 232. \$20.00 loose leaf binder. Designed as an aid to lawyers as well as retailers and other businessmen in understanding the statutes and what is required to comply with them.
- A MANUAL ON MARITAL RECONCILIATIONS. By Nester C. Kohut. Chicago: Adams Press. 1964. Pp. 100. \$1.75 paperbound. An attempt to formulate some standards for ensuring that unbroken marriages do not end up in divorce; directed at lawyer, marriage counselor and layman.
- MR. LINCOLN AND THE NEGROES. William O. Douglas. New York: Atheneum. 1963. Pp. xi, 237. \$4.95. An examination of Lincoln's philosophy, its growth, expression, and utilization to date.
- ONE MAN'S STAND FOR FREEDOM. Edited by Irving Dilliard. New York: Alfred A. Knopf. 1963. Pp. xxii, 504. \$7.50. Seventy-five of Mr. Justice Black's opinions highlighting his stand on the Bill of Rights, with a general introduction outlining the Justice's career.
- *THE PAPER ECONOMY. By David T. Bazelon. New York: Random House. 1963. Pp. 467. \$6.95.

THE POLITICS AND ECONOMICS OF EUROPEAN INTEGRATION. By U. W. Kitzinger. New York and London: Frederick A. Praeger. 1963. Pp. 246. \$5.50. A study of the political and economic ramifications of European unity, including discussions of the 1962 Trade Expansion Act, and of the impact of Common Market developments on the American economy.

THE PRESS AND FOREIGN POLICY. By Bernard C. Cohen. Princeton: Princeton University Press. 1963. Pp. ix, 288. \$6.00. Mr. Cohen offers proposals for improvements in the relationship between the press and foreign policy that would affect both policy officials and reporters.

THE QUIET CRISIS. By Stewart L. Udall. New York, Chicago, San Francisco: Holt, Rinehart and Winston. 1963. Pp. xiii, 209. \$5.00. An outline of the relationship between Americans and the land, which also sets forth what the author feels must be done in the field of conservation.

SUPPRESSED BOOKS: A HISTORY OF THE CONCEPTION OF LITERARY OBSCENITY. By Alec Craig. Cleveland and New York: The World Publishing Company. 1963. Pp. 285. \$6.00. The author, an eminent British critic, explores the conception of literary obscenity, tracing his subject from the earliest times, with special reference to recent legislation and prosecutions in the United States and England.

THE SUPREME COURT REVIEW, 1963. Edited by Philip B. Kurland. Chicago and London: The University of Chicago Press. 1963. Pp. viii, 356. \$6.50. Articles by various authors discussing the principal decisions of 1963 and the area of law in which they fit.

TAXES, LOOPHOLES AND MORALS. By Jerome R. Hellerstein. New York, Toronto, London: McGraw-Hill Book Company, Inc. 1963. Pp. ix, 245. \$5.95. The major Federal income-tax problems.

*TOO GRAVE A RISK: THE CONNALLY AMENDMENT ISSUE. By Denison Kitchel. New York: William Morrow & Co. 1963. Pp. 128. \$3.75.
