- CIVIL PROCEDURE. By Fleming James, Jr. Boston: Little, Brown & Co. 1965. Pp. xx, 747. \$12.00. A treatise on civil procedure covering pleading, discovery, trial, parties, judgments, and venue, among other topics, with historical background and documentation.
- CIVIL PROCEDURE IN SWEDEN. By Ruth Bader Ginsburg and Anders Bruzelius. The Hague: Martinus Nijhoff. 1965. Pp. lxxxiv, 491. \$17.50. This book provides a detailed description of Swedish civil procedure and is the first of a series on civil procedure in European nations.
- COMMERCIAL LAW. By E. Allen Farnsworth and John O. Honnold. Brooklyn: The Foundation Press, Inc. 1965. Pp. xiv, 1088. \$13.00. A new casebook synthesizing the authors' separate casebooks on negotiable instruments law and sales and sales financing, with emphasis upon the Uniform Commercial Code.
- THE CONSTITUTION AND THE SUPREME COURT. (2d ed.) By Wallace Mendelson. New York: Dodd, Mead & Co. 1965. Pp. 681. \$10.00. A revised case-text volume on constitutional law, containing 159 cases, including reapportionment and 1964 Civil Rights Act cases.
- *Constitutionalism in America. By Arthur E. Sutherland. New York: Blaisdell Publishing Co. 1965. Pp. xv, 618. \$9.50. The history of five constitutional ideas—rule by majority will, justice despite majorities, equality of man, diffusion of governmental power, fundamental written law—traced from the Magna Carta to modern time.
- CONTRACT LAW IN AMERICA. By Lawrence M. Friedman. Madison and Milwaukee: University of Wisconsin Press. 1965. Pp. x, 280. \$6.50. An analysis of conventional contract law as it applies to the actual workings of the legal order, in which the author demonstrates that many principles no longer have relevance to the needs of society or the courts.
- THE CRISIS OF POLITICAL IMAGINATION. By Glenn Tinder. New York: Scribners. 1965. Pp. 373. \$7.50. The author attacks the secularized notion of political thought and argues that free society depends on historical responsibility and action to reunite the individual and his political response.
- DISCRIMINATION AND THE LAW. Edited by Vern Countryman. Chicago and London: University of Chicago Press. 1965. Pp. vii, 170. \$5.00. The four basic areas of discrimination in employment, education, public accommodation, and housing are probed by a group of lawyers and legal scholars.
- *The English Bar: A Priesthood; the Tribute of an American Lawyer. By Barnett Hollander. London: Bowes and Bowes. 1964. Pp. 70. \$3.75. The author has provided an impression of the legal profession and judicial process of England.

- ESTATE PLANNING DESK BOOK (2d ed.) By William J. Casey. New York: Institute for Business Planning. 1965. Pp. 308. \$9.95. A concise reference book, with charts and tables, to assist the attorney in planning estates.
- FEDERAL FOOD, DRUG, AND COSMETIC ACT, JUDICIAL AND ADMINISTRATIVE RECORD, 1961-1964. By Vincent A. Kleinfeld and Alan H. Kaplan. Chicago: Commerce Clearing House, Inc. 1965. Pp. xiii, 913. \$27.50. The first compilation of the complete record of the Federal Food, Drug, and Cosmetic Act, containing pertinent decisions, statements of policy, and interpretations by the Agency.
- FEDERAL JURY PRACTICE AND INSTRUCTIONS—CIVIL AND CRIMINAL. By William Mathes and Edward Devitt. St. Paul: West Publishing Co. 1965. Pp. xl, 724. \$20.00. A book designed for the judge and practitioner in federal practice, providing sample jury instructions with applicable annotations.
- HANDEOOK OF EVIDENCE FOR CRIMINAL TRIALS. By Henry B. Rothblatt. Englewood Cliffs: Prentice-Hall, Inc. 1965. Pp. xv, 315. \$15.00. A new work on troublesome areas in criminal law on search and seizure and confessions, among other topics, intended to assist the attorney in preparing for trial.
- THE INTERNATIONAL LAW COMMISSION. By Herbert W. Briggs. Ithaca: Cornell University Press. 1965. Pp. 380. \$7.50. A legal and political study of an organization of the United Nations devoted to the codification and development of international law.
- INTRODUCTION TO LAW AND THE LEGAL PROCESS. By Bernard F. Cataldo, et al. London, New York and Sydney: John Wiley & Sons, Inc. 1965. Pp. xiii, 880. \$3.95. An introduction to law prepared for the business and liberal arts student.
- JUSTICE IN AMERICA; COURTS, LAWYERS AND THE JUDICIAL PROCESS. By Herbert Jacob. Boston: Little, Brown & Co. 1965. Pp. 215. \$5.00 paperbound. The author presents a political analysis of the administration of justice in American courts, in which he views the courts as units of the political system.
- LAWYER'S DESK BOOK. By William J. Casey. New York: Institute for Business Planning. 1965. Pp. vi, 810. \$17.50. A one-volume reference work covering questions that appear in daily law practice; topics include wills and trusts, estate planning, damages, business agreements, real estate, taxes, and insurance.
- MAGNA CARTA. By J. C. Holt. New York: Cambridge University Press. 1965. Pp. 377. \$11.50. A scholarly study of the Great Charter and its impact upon England and America, in which the author seeks parallels in the history of France, Sicily, Hungary, and the Spanish Kingdoms.
- MEDICARE AND SOCIAL SECURITY EXPLAINED. By the CCH Editorial Staff. Chicago: Commerce Clearing House, Inc. 1965. Pp. 176. \$2.50 paperbound. An explanatory guide on the new provisions of the Social Security law, and the Medicare Bill.

- OUR CONSTITUTION: TOOL OR TESTAMENT? By Beryl Harold Levy. Port Washington: Kennikat Press. 1965. Pp. 315. \$8.50. An explanation of the Supreme Court viewed against the profiles of Chief Justices Marshall and Taney, and Associate Justices Holmes and Brandeis.
- THE PROTECTION OF FOREIGN INVESTMENT. By Richard B. Lillich. Syracuse: Syracuse University Press. 1965. Pp. x, 222. \$7.50. Six studies systematically appraising the problems presented by foreign investment, and the efforts of Congress to offer protection in this field.
- ROSCOE POUND AND CRIMINAL JUSTICE. Edited by Sheldon Glueck. Dobbs Ferry: Oceana Publications, Inc. 1965. Pp. 261. \$7.50. A compilation of the writings of the eminent jurist in which the relationship of an orderly society is discussed with the needs of personal freedom.
- SECURITY IN DISARMAMENT. Edited by Richard A. Falk and Richard J. Barnet. Princeton: Princeton University Press. 1965. Pp. 441. \$10.00. Eleven experts explore the risks and political implications of disarmament, and suggest means of overcoming the traditional stumbling blocks.
- *West's McKinney's Forms: Business Corporation Law. By Martin Fogelman. St. Paul: West Publishing Co. 1965. Pp. lii, 1227. \$30.00. A new two-volume form book under the New York Business Corporation Law, embodying a checklist concept to aid legal counsel in preparing corporate agreements and papers; major emphasis is placed on procedure in all phases of corporate law with appropriate commentaries.
