ARRESTS, SEARCHES, CONFESSIONS. By William E. Ringel. New York: Gould Publications. 1966. Pp. xii, 328. \$6.00 paperbound. The author, a judge of the Criminal Court of the City of New York, presents a guide to the new rules in such areas as self-incrimination, testimonial compulsion, admissions and confessions, the right to assigned counsel, and obscenity.

C.P.A. LAW REVIEW: UNDER THE UNIFORM COMMERCIAL CODE (3d ed.). By Joseph L. Frasca. Homewood, Illinois: Richard D. Irwin, Inc. 1966. Pp. xix, 1282. \$16.00. Designed for accountants who wish to keep up to date with recent developments in commercial law, particularly under the Uniform Commercial Code.

FAIR PACKAGING AND LABELING ACT WITH EXPLANATION. By the CCH Editorial Staff. Chicago: Commerce Clearing House, Inc. 1966. Pp. 72. \$1.50 paperbound. A report on the impact of the Fair Packaging and Labeling Act which indicates that industry will have to take a more careful look at packaging and labeling practices.

THE FORGING OF THE FEDERAL INDIGENT CODE. By John P. Comer. San Antonio: Principia Press of Trinity University. 1966. Pp. x, 248. \$6.00. An historical study of free service to indigents in civil and criminal cases.

HANDBOOK ON LIABILITY IN PERSONAL INJURY CASES. Compiled by Sol Schreiber. New York: Practising Law Institute. 1966. Pp. 614. \$20.00. A collection of law review articles covering the entire spectrum of basic negligence concepts.

HOW TO TAKE A CASE BEFORE THE NATIONAL LABOR RELATIONS BOARD (3d ed.). By Louis G. Silverberg. Revised by Kenneth C. McGuiness. Washington: The Bureau of National Affairs, Inc. 1967. Pp. xvii, 442. \$10.50. A clear and detailed exposition of how NLRB hearings are conducted, how decisions are reached, and how rulings are enforced.

THE LAW OF MARITIME PERSONAL INJURIES (2d ed.). By Martin J. Norris. Mount Kisco, New York: Baker, Voorhis & Co., Inc. 1966. Pp. lxiv, 649. \$29.00. An aid in handling cases of injuries to harbor workers, passengers and visitors.

LAWYERS DESK REFERENCE: A SOURCE GUIDE TO SAFETY INFORMATION—WHAT TO FIND, HOW TO FIND IT. By Dean A. Robb and Harry M. Philo. Rochester: Lawyers Co-operative Publishing Co. 1966. Pp. xxix, 835. \$20.00. A valuable tool for the tort lawyer which includes information such as lists of expert witnesses and sources of medical data. Generally the authors attempt to provide new and useful information for defining and proving "reasonable care" as it is understood today.

MATRIMONIAL PRACTICE IN THE NEW YORK SUPREME COURT. By Max Hendler. New York: Practising Law Institute. 1966. Pp. xvi, 231. \$7.00. Complete with an analysis of the 1966 revision of the New York Domestic Relations Law.

MEDICAL MALPRACTICE—THE ATL SEMINAR. Edited by Louis R. Harolds and Melvin Block. Rochester: Lawyers Co-operative Publishing Co. 1966. Pp. ix, 608. \$15.00. An outgrowth of a seminar conducted by the American Trial Lawyers Association,

the book contains a compilation of various techniques used in direct and cross-examination of medical witnesses as well as other relevant information relating to the field of malpractice.

MOTOR VEHICLE AND HIGHWAY SAFETY ACTS OF 1966 WITH EXPLANATION. By the CCH Editorial Staff. Chicago: Commerce Clearing House, Inc. 1966. Pp. 141. \$2.50 paperbound. A report which furnishes background, history, comment, and explanation of The National Traffic and Motor Safety Act of 1966 and The Highway Safety Act of 1966.

THE NEW CONFESSION STANDARDS: *Miranda v. Arizona*. By Nathan R. Sobel. Jamaica, New York: Gould Publications. 1966. Pp. iii, 153. \$5.00 paperbound. An analysis of the relevant confession decisions of the last thirty years, culminating in the *Miranda* decision of 1966.

NEW YORK EVIDENCE: PROOF OF CASES (VOL. I) (2d ed.). By Gabriel V. Mottla. Rochester: Lawyers Co-operative Publishing Co. 1966. Pp. vi, 816. \$22.50. An examination of frequently occurring topics of substantive law and a presentation of the elements which must be proved, the issues on which each party has the burden of proof, and particular problems arising in areas of substantive law.

NEW YORK STANDARD CIVIL PRACTICE SERVICE: DESK BOOK (2d ed.). Edited by Robert T. Kimbrough, Joseph Rasch, Trowbridge C. Williams and Harry A. Wood. Rochester: Lawyers Co-operative Publishing Co. 1966. Pp. 2066. \$15.00. Contains the complete text of the New York CPLR, related practice provisions, rules of court and special court acts, advisory committee notes, and research references.

ROMAN VOTING ASSEMBLIES: FROM THE HANNIBALIC WAR TO THE DICTATORSHIP OF CAESAR. By Lily Ross Taylor. Ann Arbor: The University of Michigan Press. 1966. Pp. xix, 175. \$7.50. Drawing on recent archeological discoveries, the author reconstructs voting procedures of the Roman assemblies during the last two centuries of the Republic.

1966 ROUNDUP OF FEDERAL TAX LAW CHANGES. By the CCH Editorial Staff. Chicago: Commerce Clearing House, Inc. 1966. Pp. 96. \$2.00 paperbound. A non-technical compilation of the important 1966 tax law changes and what they mean to individual taxpayers.

THE RULE OF LAW AND HUMAN RIGHTS: PRINCIPLES AND DEFINITIONS. By International Commission of Jurists. Geneva: International Commission of Jurists. 1966. Pp. viii, 83. \$1.50. A correlation of the conclusions reached at various colloquia, conferences, and seminars throughout the world, applying the rule of law and the protection of human rights to international instruments of law.

STATE TAX HANDBOOK. By the CCH Editorial Staff. Chicago: Commerce Clearing House, Inc. 1966. Pp. 667. \$3.00 paperbound. A handbook outlining the features of each state's revenue system and describing statewide levies, the basis and rates of each tax, and the principal payment and return due dates.

WHEN AMERICANS COMPLAIN: GOVERNMENTAL GRIEVANCE PROCEDURES. By Walter Gellhorn. Cambridge: Harvard University Press. 1966. Pp. viii, 239. \$3.95. The author examines the procedures used by national, state, and local governments to handle grievances about official actions or failures to act, demonstrating that new procedures are needed to make protests against faulty administration meaningful.
