

STATEMENT OF APPEALS UNIT FINDINGS & RECOMMENDATION (AMENDED)

Appellant challenges the determination of the Board, denying his release and imposing a 18-month hold.

Appellant raises a number of issues in his brief, among which is the argument that the Board mistakenly stated during the interview and in its decision that Appellant shot his half-brother four times, believing that his half-brother was the deceased victim. While the deceased victim was shot four times, the identity of the victim was another man, and not Appellant's half-brother.

It is, therefore, recommended that a *de novo* interview be scheduled before different Board members.

Recommendation:

It is the recommendation of the Appeals Unit that the Board's decision be reversed and that a *de novo* interview be conducted before a panel of new Board members.
