Appellant challenges the March 2021 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is for choking, suffocating and then shooting his girlfriend, causing her death. Appellant raises many issues. One of the issues raised is the decision lacks detail.

The decision says the Board is concerned about the appellant's course of conduct before, during and after the commission of the crime. Yet the Board decision states appellant has no prior criminal record, and fails to list any troubling factor that happened after the commission of the crime. As such, the Board decision lacks sufficient detail articulating a reason for the denial. Therefore, a de novo is warranted.

Recommendation: Vacate and remand for de novo interview.




