Appellant challenges the May 2021 determination of the Board, denying release and imposing a 12-month hold. Appellant is incarcerated for two separate crimes. In one, he sold cocaine to an undercover police officer. In the second, he committed an armed robbery of a bodega, and when being chased by an off-duty police officer, shot the officer dead. Appellant raises many issues. One of the issues raised is a claim that the decision lacks details.

The Board decision gives few if any reasons as to why parole is being denied. Certainly there is no adequate articulation given as to the reasons parole was denied. As such, since the Board decision lacked adequate details, a de novo is warranted.

**Recommendation:** Vacate and remand for de novo interview.
