Appellant challenges the June 2021 determination of the Board, denying release and imposing a 24-month hold. Appellant is incarcerated for two separate crimes. In the first, he stabbed the victim 10 times with a knife, causing his death. In the second, he stabbed the victim in the chest and in the leg. Appellant raises many issues. One of the issues raised is a claim that the decision is based upon erroneous information. Specifically, the Board decision made mistakes concerning the COMPAS decision.

The Board decision says appellant's COMPAS scores are medium for both felony violence and for arrests. However, as appellant points out, his COMPAS scores in those two categories are low, and not medium. Thus, the decision is based upon erroneous information, and a de novo interview is warranted.

Recommendation: Vacate and remand for de novo interview.


