<u>Findings</u>: (Page 1 of 1)

Appellant challenges the June 2021 determination of the Board, denying release and imposing a 18-month hold. Appellant's instant offense is for sneaking into the bedroom of his adopted mother when she was sleeping and stabbing her to death. Appellant was 14 years old at the time. Appellant raises many issues. One of the issues raised is a claim that the decision lacks details.

A review of the Board decision indicates a lack of articulation as to why parole release is being denied. As such, since the decision is not properly detailed, a de novo interview is warranted.

<u>Recommendation</u>: Vacate and remand for de novo interview.
