Findings: (Page 1 of 1)

Appellant challenges the June 2021 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is for shooting the victim to death. Appellant raises many issues. One of the issues raised is a claim that the Board departed from the COMPAS, but failed to specify the scales or provide individualized reasons for doing so.

The Board decision states that if released there is a reasonable probability appellant would not remain at liberty without violating the law. The Board decision acknowledges the low COMPAS scores for the scales of arrest risk and risk of felony violence, but then failed to provide any reasons or details as to why the appellant would be such a risk. As such, since the COMPAS departure was not properly done, a de novo is warranted.

**<u>Recommendation</u>**: Vacate and remand for de novo interview.
