Findings: (Page 1 of 1)

Appellant challenges the July 2021 determination of the Board, denying release and imposing a 18-month hold. Appellant's is incarcerated for three separate crimes. In the first, he fired his gun at two people, striking one of them, which caused his death. In the second, while confined in State prison, he hid a weapon (a can lid) inside the sole of his shoe. In the third, again while confined in State prison, he possessed dangerous contraband which was a sharpened toothbrush. Appellant raises many issues.

The Board decision is based partially upon an opposition letter by the Office of the District Attorney from one of his convictions. A review of this letter by the Appeals Unit shows the letter is actually in favor of appellant's parole release. Since the decision is based upon erroneous information, a de novo interview is required.

Recommendation: Vacate and remand for de novo interview.




