Findings: (Page 1 of 1)

Appellant challenges the August 2021 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is for killing his father and his father's girlfriend. Appellant raises many issues. One of the issues raised is a claim the Board never contacted appellant's former criminal defense lawyer.

A letter was sent in 2010 to the Clerk of the Court, asking them to contact the former criminal defense lawyer. Given the amount of information available in 2010, a more diligent effort should have been made. As the lawyer has now been contacted and does wish to submit a favorable parole recommendation, a de novo interview is warranted.

Recommendation: Vacate and remand for de novo interview.
