



Appellant challenges the April 2022 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is for stabbing two women, resulting in the death of one of them and severe injuries to the second. Appellant raises many issues. One of appellant's claims is the Board decision lacks details.

The Board decision is somewhat confusing as to exactly why parole release is being denied. Thus, due to failure to articulate the denial reasons in sufficient detail, a de novo interview is warranted.

**Recommendation:** Vacate and remand for de novo interview.
