Findings: (Page 1 of 4)

Appellant challenges the November 2018 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is being a part of a contract murder of a police officer guarding a witness. Appellant raises the following issues: 1) the decision is arbitrary and capricious in that the Board failed to consider and/or properly weigh the required statutory factors. 2) the decision was predetermined. 3) the decision does what prior decisions did and only looks at the instant offense and criminal history. 4) the decision violates the due process clause of the constitution. 5) the Board ignored the positive portions of his COMPAS. 6) as appellant has been in prison for over 30 years, the Board shouldn't state his release would deprecate the seriousness of his crime.

Discretionary release to parole is not to be granted "merely as a reward for good conduct or efficient performance of duties while confined but after considering if there is a reasonable probability that, if such inmate is released, he will live and remain at liberty without violating the law, and that his release is not incompatible with the welfare of society and will not so deprecate the seriousness of his crime as to undermine respect for the law." Executive Law § 259-i(2)(c)(A) (emphasis added); accord Matter of Hamilton v. New York State Div. of Parole, 119 A.D.3d 1268, 990 N.Y.S.2d 714 (3d Dept. 2014). Executive Law § 259-i(2)(c)(A) requires the Board to consider criteria which is relevant to the specific inmate, including, but not limited to, the inmate's institutional record and criminal behavior. People ex rel. Herbert v. New York State Bd. of Parole, 97 A.D.2d 128, 468 N.Y.S.2d 881 (1st Dept. 1983). While consideration of these factors is mandatory, "the ultimate decision to parole a prisoner is discretionary." Matter of Silmon v. Travis, 95 N.Y.2d 470, 477, 718 N.Y.S.2d 704, 708 (2000). Thus, it is well settled that the weight to be accorded the requisite factors is solely within the Board's discretion. See, e.g., Matter of Delacruz v. Annucci, 122 A.D.3d 1413, 997 N.Y.S.2d 872 (4th Dept. 2014); Matter of Hamilton, 119 A.D.3d at 1271, 990 N.Y.S.2d at 717; Matter of Garcia v. New York State Div. of Parole, 239 A.D.2d 235, 239, 657 N.Y.S.2d 415, 418 (1st Dept. 1997). The Board need not explicitly refer to each factor in its decision, nor give them equal weight. Matter of Betancourt v. Stanford, 148 A.D.3d 1497, 49 N.Y.S.3d 315 (3d Dept. 2017); Matter of LeGeros v. New York State Bd. of Parole, 139 A.D.3d 1068, 30 N.Y.S.3d 834 (2d Dept. 2016); Matter of Phillips v. Dennison, 41 A.D.3d 17, 21, 834 N.Y.S.2d 121, 124 (1st Dept. 2007).

Although the Board placed emphasis on the crime, the record reflects it also considered other appropriate factors and it was not required to place equal weight on each factor considered. <u>Matter of Peralta v. New York State Bd. of Parole</u>, 157 A.D.3d 1151, 69 N.Y.S.3d 885 (3d Dept. 2018); <u>Matter of Arena v. New York State Dep't of Corr. & Cmty. Supervision</u>, 156 A.D.3d 1101, 65 N.Y.S.3d 471 (3d Dept. 2017); <u>Matter of Gordon v. Stanford</u>, 148 A.D.3d 1502, 50 N.Y.S.3d 627 (3d Dept. 2017)(shooting of police officer); <u>Matter of Mullins v. New York State Bd. of Parole</u>, 136 A.D.3d 1141, 25 N.Y.S.3d 698 (3d Dept. 2016).

<u>Findings</u>: (Page 2 of 4)

The Board could place greater emphasis on the serious nature of the crime that involved shooting a police officer in the head. <u>Francis v New York State Division of Parole</u>, 89 A.D.3d 1312, 934 N.Y.S.2d 514 (3d Dept. 2011), <u>MacKenzie v Evans</u>, 95 A.D.3d 1613, 945 N.Y.S.2d 471 (3d Dept. 2012).

The Board may emphasize the nature of the instant offense and that it was an escalation in illegal behavior. <u>See Matter of Stanley v. New York State Div. of Parole</u>, 92 A.D.3d 948, 948-49, 939 N.Y.S.2d 132, 134 (2d Dept.), <u>lv. denied</u>, 19 N.Y.3d 806, 949 N.Y.S.2d 343 (2012); <u>Matter of Symmonds v. Dennison</u>, 21 A.D.3d 1171, 1172, 801 N.Y.S.2d 90, 90 (3d Dept.), <u>lv. denied</u>, 6 N.Y.3d 701, 810 N.Y.S.2d 415 (2005); <u>Matter of Warren v. New York State Div. of Parole</u>, 307 A.D.2d 493, 493, 761 N.Y.S.2d 883 (3d Dept. 2003); <u>Matter of Garcia v. New York State Div. of Parole</u>, 239 A.D.2d 235, 239-40, 657 N.Y.S.2d 415, 418 (1st Dept. 1997).

The Board may take note of the inmate's disregard for the life of another human being. <u>Hakim v</u> <u>Travis</u>, 302 A.D.2d 821, 754 N.Y.S.2d 600 (3d Dept 2003); <u>Angel v Travis</u>, 1 A.D.3d 589, 767 N.Y.S.2d 290 (3d Dept 2003).

The Board may consider negative aspects of the COMPAS instrument. <u>Matter of Espinal v. New</u> <u>York Bd. of Parole</u>, 2019 NY Slip Op 04080, 2019 N.Y. App. Div. LEXIS 4057 (3d Dept. May 23, 2019) (COMPAS instrument yielded mixed results); <u>Matter of Bush v. Annucci</u>, 148 A.D.3d 1392, 50 N.Y.S.3d 180 (3d Dept. 2017) (COMPAS instrument with mixed results including substance abuse relevant given use before crime); <u>Matter of Wade v. Stanford</u>, 148 A.D.3d 1487, 52 N.Y.S.3d 508 (3d Dept. 2017) (low risk felony violence but probable risk for substance abuse alcohol related crimes); <u>Matter of Crawford v. New York State Bd. of Parole</u>, 144 A.D.3d 1308, 46 N.Y.S.3d 228 (3d Dept. 2016) (scores not uniformly low including family support), <u>lv. denied</u>, 29 N.Y.3d 901, 57 N.Y.S.3d 704 (2017).

There is no evidence the Board's decision was predetermined based upon the instant offense. <u>Matter of Gonzalvo v. Stanford</u>, 153 A.D.3d 1021, 56 N.Y.S.3d 896 (3d Dept. 2017); <u>Matter of Hakim-Zaki v. New York State Div. of Parole</u>, 29 A.D.3d 1190, 814 N.Y.S.2d 414 (3d Dept. 2006); <u>Matter of Guerin v. New York State Div. of Parole</u>, 276 A.D.2d 899, 695 N.Y.S.2d 622 (3d Dept. 2000). There is a presumption of honesty and integrity that attaches to Judges and administrative fact-finders. <u>See People ex rel. Carlo v. Bednosky</u>, 294 A.D.2d 382, 383, 741 N.Y.S.2d 703 (2d Dept. 2002); <u>People ex. rel. Johnson v. New York State Bd. of Parole</u>, 180 A.D.2d 914, 916, 580 N.Y.S.2d 957, 959 (3d Dept. 1992). The Board is presumed to follow its statutory commands and internal policies in fulfilling its obligations. <u>See Garner v. Jones</u>, 529 U.S. 244, 256, 120 S. Ct. 1362, 1371 (2000). Appellant has failed to overcome the presumption that the Board complied with its duty. <u>See Matter of Davis v. New York State Div. of Parole</u>, 114 A.D.2d 412, 494 N.Y.S.2d 136 (2d Dept. 1985).

As for an alleged similarity to prior Board decisions, since the Board is required to consider the same statutory factors each time an inmate appears before it, it follows that the same aspects of the individual's record may again constitute the primary grounds for a denial of parole. <u>Matter of Hakim v. Travis</u>, 302 A.D.2d 821, 754 N.Y.S.2d 600 (3d Dept. 2003); <u>Matter of Bridget v. Travis</u>, 300 A.D.2d 776, 750 N.Y.S.2d 795 (3d Dept. 2002). The Board is required to consider the same factors each time he appears in front of them. <u>Matter of Williams v. New York State Div. of Parole</u>, 70 A.D.3d 1106, 894 N.Y.S.2d 224 (3d Dept.), <u>Iv. denied</u>, 14 N.Y.3d 709, 901 N.Y.S.2d 143 (2010).

An inmate has no Constitutional right to be conditionally released on parole before expiration of a valid sentence. <u>Greenholtz v. Inmates of Nebraska Penal & Correctional Complex</u>, 442 U.S. 1, 99 S. Ct. 2100, 2104 (1979); <u>Matter of Russo v. Bd. of Parole</u>, 50 N.Y.2d 69, 427 N.Y.S.2d 982 (1980); <u>Matter of Vineski v. Travis</u>, 244 A.D.2d 737, 664 N.Y.S.2d 391 (3d Dept. 1997). The New York State parole scheme "holds out no more than a possibility of parole" and thus does not create a protected liberty interest implicating the due process clause. <u>Matter of Russo</u>, 50 N.Y.2d at 75-76, 427 N.Y.S.2d at 985; <u>see also Barna v. Travis</u>, 239 F.3d 169, 171 (2d Cir. 2001); <u>Matter of Freeman v. New York State Div. of Parole</u>, 21 A.D.3d 1174, 800 N.Y.S.2d 797 (3d Dept. 2005). That the inmate has served his minimum sentence does not give him a protected liberty interest in parole release. <u>Matter of Russo v. Bd. of Parole</u>, 50 N.Y.2d 69, 427 N.Y.S.2d 982 (1980); <u>Matter of Motti v. Alexander</u>, 54 A.D.3d 114, 115, 863 N.Y.S.2d 839, 839-40 (3d Dept. 2008); <u>Matter of Warren v. New York State Div. of Parole</u>, 307 A.D.2d 493, 493, 761 N.Y.S.2d 883, 883 (3d Dept. 2003); <u>Matter of Vineski v. Travis</u>, 244 A.D.2d 737, 664 N.Y.S.2d 391 (3d Dept. 1997).

Nothing in the due process clause requires the Parole Board to specify the particular evidence on which rests the discretionary determination an inmate is not ready for conditional release. <u>Duemmel v Fischer</u>, 368 Fed.Appx. 180, 182 (2d Cir. 2010). There is no due process requirement that the Parole Board disclose its release criteria. <u>Haymes v Regan</u>, 525 F.2d 540 (2d Cir. 1975). The due process clause is not violated by the Board's balancing of the statutory criteria, and which is not to be second guessed by the courts. <u>Mathie v Dennison</u>, 2007 WL 2351072 (S.D.N.Y. 2007); <u>MacKenzie v Cunningham</u>, 2014 WL 5089395 (S.D.N.Y. 2014).

Parole is not constitutionally based, but is a creature of statute which may be imposed subject to conditions imposed by the state legislature. <u>Banks v Stanford</u>, 159 A.D.3d 134, 71 N.Y.S.3d 515 (2d Dept. 2018).

The Board provided its statutory rationale for denying parole. <u>Matter of Murray v. Evans</u>, 83 A.D.3d 1320, 920 N.Y.S.2d 745 (3d Dept. 2011) (Board provided adequate statutory rationale). That the Board "did not recite the precise statutory language of Executive Law § 259-i (2)(c)(A) in support of its conclusion to deny parole does not undermine its conclusion." <u>Matter of Mullins v. New York State Bd. of Parole</u>, 136 A.D.3d 1141, 1142, 25 N.Y.S.3d 698 (3d Dept. 2016) (citation omitted); <u>accord Matter of Reed v. Evans</u>, 94 A.D.3d 1323, 942 N.Y.S.2d 387 (3d Dept.

2012). The language used by the Board was "only semantically different" from the statute. <u>Matter of Miller v. New York State Div. of Parole</u>, 72 A.D.3d 690, 691–92, 897 N.Y.S.2d 726, 727 (2d Dept. 2010); <u>Matter of James v. Chairman of New York State Div. of Parole</u>, 19 A.D.3d 857, 858, 796 N.Y.S.2d 735, 736 (3d Dept. 2005); <u>see also People ex rel. Herbert v. New York State Bd. of Parole</u>, 97 A.D.2d 128, 468 N.Y.S.2d 881 (1st Dept. 1983) (upholding decision that denied release as "contrary to the best interest of the community").

Denial of parole is neither arbitrary nor capricious when the Parole Board relied on the factors defined by the New York statute. <u>Hodge v Griffin</u>, 2014 WL 2453333(S.D.N.Y. 2014) citing <u>Romer v Travis</u>, 2003 WL 21744079. An arbitrary action is one without sound basis in reason and without regard to the facts. Rationality is what is reviewed under an arbitrary and capricious standard. <u>Hamilton v New York State Division of Parole</u>, 119 A.D.3d 1268, 990 N.Y.S.2d 714 (3d Dept. 2014). An action is arbitrary and capricious when it is taken without sound basis in reason or regard to the facts. <u>Ward v City of Long Beach</u>, 20 N.Y.3d 1042 (2013). Denial is neither arbitrary nor capricious when the Board relies on factors defined by New York statute. <u>Siao-Paul v. Connolly</u>, 564 F. Supp. 2d 232, 242 (S.D.N.Y. 2008); <u>Hanna v New York State Board of Parole</u>, 169 A.D.3d 503, 92 N.Y.S.3d 621 (1st Dept. 2019).

In the absence of a convincing demonstration that the Board did not consider the statutory factors, it must be presumed that the Board fulfilled its duty. <u>Matter of Fuchino v. Herbert</u>, 255 A.D.2d 914, 914, 680 N.Y.S.2d 389, 390 (4th Dept. 1998); <u>Matter of McLain v. New York State Div. of Parole</u>, 204 A.D.2d 456, 611 N.Y.S.2d 629 (2d Dept. 1994); <u>Matter of McKee v. New York State Bd. of Parole</u>, 157 A.D.2d 944, 945, 550 N.Y.S.2d 204, 205 (3d Dept. 1990); <u>People ex rel.</u> Herbert, 97 A.D.2d 128, 468 N.Y.S.2d 881.

Recommendation: Affirm.
