<u>Findings</u>: (Page 1 of 1)

Appellant challenges the January 2021 determination of the Board, denying release and imposing a 24-month hold. Appellant's instant offense is for viewing child pornography on his computer. Appellant raises many issues. One of the issues raised is a sentence in the Board decision stating the Board had reviewed his sentencing minutes.

As was stated during the interview, the Board had requested but not received the sentencing minutes. And in fact the Board did not have the sentencing minutes. As such, the decision is based upon erroneous information. Thus, a de novo interview is warranted.

<u>Recommendation</u>: Vacate and remand for de novo interview.
