**<u>Findings</u>**: (Page 1 of 1)

Appellant challenges the August 2021 determination of the Board, denying release and imposing a 24-month hold. The instant offense involved Appellant punching a 12-year-old girl until she was unconscious and dragging her into a wooded area. Appellant then sexually abused the victim and attempted to rape her before strangling her and causing her death by hitting her with a rock. Among other things, Appellant argues that the Board departed from the COMPAS and failed to specify the scale and the individualized reasons for the departure.

A review by the Appeals Unit reveals the Board found a reasonable probability that Appellant would reoffend and did not specify a scale or provide an explanation for the departure from his low COMPAS scores. 9 NYCRR § 8002.2(a).

**<u>Recommendation</u>**: Vacate and remand for de novo interview.
