<u>Findings</u>: (Page 1 of 1)

Appellant challenges the October 2021 determination of the Board, denying release and imposing a 15-month hold. Appellant's instant offenses involve him committing two armed robberies, and in one of the robberies, shooting the victim to death. Appellant raises many issues. Two of the issues raised are the decision lacks detail, and the Board failed to provide individualized scales when departing from the COMPAS.

A review by the Appeals Unit shows the decision fails to articulate and tie together specific reasons for the denial. And because of this, it is unclear if the Board departed from the COMPAS or not. As such, since appellate review has been frustrated, a de novo interview is warranted.

<u>Recommendation</u>: Vacate and remand for de novo interview.
