## SPECIAL ANNOUNCEMENT

The war and the exigencies of military and naval service have created special difficulties and problems for students seeking to secure a legal education. Because of the expressed desires of many students in the School, as well as of applicants seeking to commence their law studies this year, that an accelerated program of study be offered to enable completion of as much of their professional study as possible prior to entry into the armed forces of the United States, the Faculty of the Fordham University School of Law announces the following changes in the program of courses offered.

A summer term of fourteen weeks will be offered in both the day and evening division in all years of the School. In the day division, fourteen periods a week of classroom attendance will be required. In the evening division, ten periods a week in the first and second years, and twelve periods a week in the third and fourth years, will be required. The increase in the weekly classroom time will permit completion of the same amount of work in the summer session as in the regular fall or spring terms, where only the usual weekly hours of attendance will be necessary. The summer session will begin on June 15th, 1942, and will continue until September 19th, 1942. In the day school, sessions will be held on every weekday from Monday to Friday. inclusive, beginning at 9:30 A.M. Elective courses will be offered on Saturday mornings. In the evening school, sessions will be held on every day from Monday to Thursday, inclusive, beginning at 5:30 P.M. Because of the change in time, made effective by Presidential order for the duration of the war, this will enable completion of each day's lectures before darkness.

Students will not be required to pursue the accelerated program, and those who do not find it necessary to do so are advised to take merely the regular fall and spring terms in each year.

Students beginning the study of law may start their studies either on June 15, 1942, September 28, 1942, or February 1, 1943, on all of which dates a regular First Year program of law study in both the day and evening divisions will commence. Students who elect to take three terms in each calendar year, may complete the three-year day course in two calendar years, or the four-year evening course in a little over two and two-third calendar years.

Application for the June term will be received from April 15, 1942 to the opening of classes; for the September term, from June 15, 1942 to the opening of classes; and for the February term from December 1st to the opening of classes. Where an applicant, by reason of residence
